

NP Screen Web Portal – Terms of Use Agreement

BINDING AGREEMENT:

This Agreement, (the “Agreement”) between NP Screen Inc. carrying on business as NP Screen (“NP Screen”) and you governs your use of **NP Screen Web Portal (the “Website”)** and all contents made available on it.

1) ACCEPTANCE:

- a) You indicate your acceptance of this Agreement by taking one of the following actions: (i) physically signing a paper copy of this document; (ii) clicking on “Accept” where an electronic version of this document is presented to you, (iii) transmitting information over the Website or (iv) by entering into any other agreement with NP Screen or an affiliate of NP Screen regarding the transmittal of information and use of the Website .
- b) As provided elsewhere in this Agreement, NP Screen may revise this Agreement or the Website at any time in NP Screen’s sole discretion without prior notice. The terms of use displayed each time the user accesses the Website will reflect such revisions as required. Notification of any change will appear on the Website’s homepage for 21 days following such change
- c) If you do not agree to the terms contained herein OR should you not agree to any change in these terms subsequently made by NP Screen, you will not be provided with access to the Website.

2) INTELLECTUAL PROPERTY:

- a) Certain names, graphics, logos, icons, designs, words, titles or phrases on the Website may constitute trademarks, service marks, trade names, trade dress or products of NP Screen or other entities. The trademarks, service marks, trade names, trade dress and products represented on the Website are protected in Canada and internationally and their display on the Website does not convey or create any license or other rights in these marks, names, dress or products. No use of these may be made without prior written authorization of NP Screen, except to identify the products or services of NP Screen. NP Screen either owns the intellectual property rights in the underlying Hyper Text Management Language (“HTML”) and content made available on the Website or has obtained the permission of the owner of the intellectual property in such content for use on the Website. All content on the Website is protected by worldwide copyright laws.
- b) NP Screen grants to you a limited license to display on your computer, print, download and use the underlying HTML and content for the screening of your insurance applicants, care and treatment of your patients, for research within the ordinary course of your profession or employment and for other non- commercial, personal or educational purposes, provided that you do not modify any such content and you include with and display on each copy of such content the associated copyright notice and this limited licence.
- c) NP Screen grants users a limited licence to display, download, print and use content accessed through the Website for the purpose of assisting in providing health care to individuals or medical research and not for any other purpose and on the condition that users do not adapt, modify, decompile or disassemble, or reverse engineer any aspect of the Website or any software or technology used in connection with the Website.

3) SERVICES PROVIDED:

- (a) The services provided by NP Screen to custodians of personal health information through this Website is restricted to facilitating the transmission of information including personal health information from physicians conducting tests of patients to laboratories analyzing test results and the transmission of test results from laboratories to physicians initially conducting the applicable tests.
- (b) if you are a custodian of personal health information transmitting such information through the Website NP Screen agrees to perform and provide to you from time to time as required by applicable privacy legislation including the Act a threat risk assessment and privacy impact assessment relating to the services provided by NP Screen to you through use of the Website.

4) SECURITY:

NP Screen will ensure a secure environment through currently accepted Internet security technologies and practices to protect the information on the Website including any information considered to be personal health information. Such measures include using a firewall to prevent unauthorized access, a Secure Sockets Layer (“SSL”) protocol with support up to 1024-bit encryption and automatic log-off after fifteen (15) minutes of inactivity. In addition NP Screen will implement such technical and physical safeguards regarding personal health information transmitted through the Website as may be required from time to time by applicable privacy legislation including legislation relating to the protection of personal health information.

5) CONFIDENTIALITY AND PRIVACY

a) All personal information about you, your employees, your practice and your business will be kept private and used only by NP Screen unless otherwise required by law or permitted by your consent.

b) You will, at all times during the term of this Agreement and thereafter, comply with all legal requirements, codes of ethics and professional standards applicable to your profession applicable to you that governs the use, disclosure, and storage of the information relating to your patients on the Website including all information considered to be personal health information under applicable legislation (“Patient Information”).

c) You will be solely responsible for obtaining all patient and other legally necessary consents including but not limited to those required by any statutes, regulations, professional standards and codes of ethics to disclose the Patient Information to you on the Website.

d) NP Screen will not assume any responsibility for your use or misuse of Patient Information or other information transmitted, stored, or received using the Website. Users are solely responsible for obtaining patient consents, whenever required, to use the Website and any personal information accessed through the Website.

e) NP Screen will keep confidential information provided for the purpose of registering as a user of the Website (“**Registration Information**”) confidential to the extent that such information is personal information and will only use or disclose Registration Information to: i) register persons to use the Website; (ii) verify the identify of persons registering or registered to use the Website; (iii) maintain and administer the registration of such persons, including the monitoring of the manner in which such persons use the Website; (iv) communicate with users about the Website; and to (v) comply with applicable legal requirements.

e) NP Screen agrees to comply with the requirements of Personal Health Information Protection Act of the Province of Ontario (the “**Act**”) and the regulations thereunder as may be applicable to it as an information technology service provider within the meaning of such Act.

6) SECURE ACCESS:

a) It is your responsibility to ensure that all information you provide to NP Screen, including without limitation the information on enrollment forms are current, accurate and complete and that you inform NP Screen of all changes in a timely manner using the forms and methods prescribed by NP Screen.

b) To access the Website you will require a username and a password (“Identifier” or “User Credentials”). You are solely responsible for maintaining the strict confidentiality of the Identifiers assigned to you and you are not permitted to disclose your Identifiers to anyone. Breach of this requirement will result in your immediate denial of access to the Website.

c) NP Screen is not liable for any harm arising from the theft of your Identifiers, your disclosure of your Identifiers, or your authorization to allow another person or entity to access the Website using your Identifiers. You agree to immediately notify NP Screen of any unauthorized use of your Identifiers or other need to deactivate any Identifiers due to security concerns.

7) SHARED ACCESS:

- a) The Website is intended for access and use solely by you, and employees and other physicians authorized by you (collectively "Delegates").
- b) You are responsible to: (i) Identify the Delegates who should be permitted access to the Website to NP Screen; (ii) Advise NP Screen of any changes in the Delegates in a timely manner using the forms and methods prescribed by NP Screen; (iii) Supervise and control the use of the Website and its contents by the Delegates; and (iv) Advise NP Screen immediately to terminate the identifier of a Delegate, using the forms and methods prescribed by NP Screen in the event a Delegate ceases to be your employee or if you wish for any reason to terminate the ability of such Delegate to access and use the Website.
- c) You may not provide your identifier to Delegates. They will be assigned their own Identifiers to log on and may view the files you have indicated they are authorized to view. Delegates will not be able to view any records in respect of which NP Screen has received a written letter from a patient restricting the sharing of his/her file.
- d) You agree that you will not, in connection with your use of the Website: (i) impersonate any person or entity, including, but not limited to, an officer, employee or representative of NP Screen, or falsely state or otherwise misrepresent your affiliation with a person or entity; (ii) interfere with, disrupt or damage the Website or servers or networks connected to the Website, or disobey any requirements, procedures, policies or regulations of networks connected to the Website; (iii) violate any applicable local, provincial, state, national or international law, and any regulations having the force of law; or (iv) access the Website after your account or access has been suspended or terminated by NP Screen.
- e) You agree not to use any crawler, spider or other program that simulates human activity to automatically extract any content accessible on or via the Website.

8) GENERAL DISCLAIMERS:

- a) The Website is provided "as is" and NP Screen expressly disclaims all express, implied, and statutory warranties or conditions, including, without limitation, the warranties or conditions of merchantability, fitness for a particular purpose, title and non-infringement of rights. Without limiting the foregoing, NP Screen does not warrant that the Website will be available at all times, will operate without errors, will be accessible regardless of the hardware or software that a user employs to access it, is absolutely secure or is free from viruses or other harmful code. All exclusions of responsibility or liability set out in this Agreement are made to the fullest extent permitted by law.
- b) You are responsible for taking all precautions you believe necessary or advisable to protect yourself against any claim, damage, loss or hazard that may arise by virtue of your use of the Website. Without limitation, if you propose to download data from the Website to any third-party application used by you, it is your responsibility to ensure that such application is compatible and is able to process the data accurately
- c) NP Screen (which, for the purposes of this section includes its officers, employees, representatives and suppliers) will not be responsible or liable to you or any other entity for any direct, compensatory, indirect, incidental, special, exemplary, or punitive damages that result from or relate in any manner whatsoever to your use of the Website, including without limitation, the failure to comply with any requirement, the loss of data, the loss of computer use or security breaches. The foregoing exclusion will apply regardless of whether NP Screen has been advised of the possibility of such damages.

b) You may terminate this Agreement by providing NP Screen with written notice of your termination and ceasing to use or access the Website.

c) NP Screen may terminate this Agreement and Your right to access and use the Website at any time, with or without cause.

d) NP Screen reserves the right to discontinue or make changes to the Website at any time.

e) Sections 3.1, 5, 8.3 and 10 of this Agreement survive the expiration or termination of this Agreement for any reason whatsoever.

13) GOVERNING LAW and JURISDICTION:

The Website (excluding third party linked websites) is controlled by NP Screen from its offices within the Province of Ontario, Canada. By accessing this Website, You and NP Screen agree that all matters relating to the access to, or use of, the Website shall be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein. c) If any provision of this Agreement shall be held by a court of competent jurisdiction to be contrary to law, the remaining provisions of this Agreement will remain in full force and effect.
